PensionsEurope is an International non-profit organisation based in Brussels **representing national associations of pension funds for workplace and other funded pensions.** Many of our members operate also personal pension schemes.

We have **25 member associations in 18 EU Member States** and **4 other European countries** covering pensions for more than 100 million people in Europe and investing over **€7 trillion for pensions.** We aim to cover all countries in Europe.

PensionsEurope **has 20 Corporate and Supporter Members** which are various **service providers and stakeholders that work with pension funds.** Membership is also open to asset managers, banks, custodians, law firms and social partners.

**The aim of PensionsEurope is that people in Europe will have good pensions.** The European pensions landscape is very diverse and pensions come in different forms in different countries. We advocate at European and international level for good funded pensions covering more people.
